CLARIFICATION

This Memorandum of Understanding (MoU) sets forth the terms of agreement and understanding signed by the same on dated, **24th March 2021**, between Govt. Aizawl West College, Dawrpui Vengthar, Aizawl, Mizoram, herein, referred to as **the first party** and Lailen Consulting Private Limited, Tuikhuahtlang, Aizawl, herein, referred to as **the second party**.

BACKGROUND

This Memorandum of Understanding (MoU) is entered into by the above-mentioned parties in order to promote and provide consultancy services as well as software/systems development and upgradation.

DURATION

This Memorandum of Understanding (MoU) is signed by the parties for a period of **2 years**, which will come into effect from the date of the signing of this MoU by both the parties concerned.

PURPOSE

This MoU is intended to achieve the following objectives:

1. To provide consultancy services on the implementation of software applications for the college.
2. To provide necessary training to the staff and students of the first party on theoretical and practical knowledge of the importance and usage of software applications.

TERMINATION OF THE AGREEMENT

If any of the signatory parties to this Agreement desired to terminate the Agreement before the expiry of the stipulated agreement period, the party initiating the termination of the agreement, shall, in writing, intimate the other party, clearly stating their reasons for terminating the Agreement, at least **30 days prior**, after which the Agreement may be terminated only if both the parties gave their consent to it.

TERMS OF AGREEMENT

1. The second party shall provide consultancy services for the implementation of College MIS software application, and impart necessary training and capacity building necessary for the same at free of cost.
2. The first party shall utilize any platforms developed by the second party, both paid or free versions (if any) for academic and administrative purposes as and when required.
3. For the Online Admission software, an annual fee of ₹30,000 (Thirty thousand) inclusive of GST, shall be charged by the second party without any hidden cost.

4. The cost, annual fee, and duration of a new contract will be revised at the end of the present contract period.
5. In case of malfunction of the software, the second party shall put the software in order at their own expenditure within 48 hours from the report made by the first party.
6. The services provided by the second party that may incur additional charges will be billed directly to the first party with a separate invoice.


OTHER MATTERS

Any other matter not mentioned or provided in the above-stated Terms of Agreement shall be cordially discussed and agreed upon by both parties accordingly. No party shall undertake initiatives, apart from the terms mentioned in the Agreement independently.
