NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause-1

CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations.
- 1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing suitable lecture/ training systems, keeping in mind the needs of the First Party.

Clause-2

SCOPE OF THE MOU

- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their knowledge.
- 2.2 The Second Party will give valuable inputs to the First Party in teaching/ training so that the students are prepared meaningfully. The First Party will provide its Classrooms/Auditorium with other necessary requirements for the said purpose.
- 2.3 The Second Party will actively engage to help the delivery of Job Opportunities to the students of the First Party.

VALIDITY

- 3.3 Any dispute arises may be settled within the jurisdiction of High Court, Mizoram Bench only.


